**Mayor & Borough Council Meeting Minutes**

**OPEN SESSION**

Mayor Canose opened the meeting to the public session.

Ed English, Olde Town Court, asked permission to have a local band play at the Farmers' Market a number of times this season including this Saturday. Council consent was given.

Hearing no further comments, Mayor Canose closed the open session.

**RESOLUTIONS**

Mr. Donahue moved to adopt **Resolution #20-165, INTRODUCTION OF 2020 MUNICIPAL BUDGET**, and that the budget be published according to law, and that a public hearing be scheduled for a meeting beginning at 7:00 p.m., Monday, July 13, 2020. Ms. Zamarra seconded the motion and a roll call vote followed. Mr. Donahue, Mr. Hammond, Ms. McCredie, Mr. McQueen, Mr. O’Dea, and Ms. Zamarra voted yes.

Mr. O’Dea moved to adopt **Resolution #20-167 APPROVING EMERGENCY TEMPORARY APPROPRIATIONS**. Ms. Zamarra seconded the motion and a roll call vote followed. Mr. Donahue, Mr. Hammond, Ms. McCredie, Mr. McQueen, Mr. O’Dea, and Ms. Zamarra voted yes.

Mayor Canose said Mr. Mastrobuono can start making calls to get people scheduled and asked about a time frame for opening the pool. Mr. Mastrobuono said it would be approximately July 6<sup>th</sup>. Ms. McCredie said vendors are on standby and asked if we could inform them right away. Mayor Canose said yes as it has now been approved.

Mr. McQueen and Ms. McCredie thanked Mr. Mastrobuono and the Recreation Committee for their efforts in preparation of getting the pool open as soon as possible.
