

**BERNARDSVILLE BOROUGH  
ORDINANCE #2016-1728**

**AN ORDINANCE CONCERNING PARKING REGULATIONS ON OLCOTT AVENUE  
AND AMENDING CHAPTER VII OF THE BOROUGH CODE ENTITLED “TRAFFIC”**

**STATEMENT OF PURPOSE:** To change the parking regulations on Olcott Avenue to allow more parking for high school students during the day closer to the school

---

**BE IT ORDAINED** by the Council of the Borough of Bernardsville in the County of Somerset, New Jersey, that Chapter VII of the Borough Code entitled “Traffic” is hereby amended as follows:

**Section 1.** Subsection 7-7.8 entitled “Parking Time Limited on Certain Streets” is hereby amended as follows<sup>1</sup>:

**7-7.8 Parking Time Limited on Certain Streets**

No person shall park a vehicle for longer than the time limit between the hours listed on any day upon any of the streets or parts of streets described.

<b>Name of Street</b>	<b>Sides</b>	<b>Maximum Times</b>	<b>Hours</b>	<b>Location</b>
Olcott Avenue	South	2 hours	7:00 a.m. to 6:00 p.m. (Monday thru Friday)	Beginning 35 feet measured easterly from the easterly curblin <u>e</u> of Anderson Road on the west to a point 421 feet in an easterly direction.
Olcott Avenue	North	2 hours	7:00 a.m. to 6:00 p.m. (Monday thru Friday)	Beginning <u>25</u> 35 feet measured east from the easterly curblin <u>e</u> of Old Army Road to a point <u>25</u> 35 feet west from the westerly curblin <u>e</u> of Highview Avenue

**Section 3.** The effectiveness of this ordinance is contingent upon signs being erected as required by law.

**Section 4.** Any or all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

**Section 5.** In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 6.** This ordinance shall become effective immediately upon final passage and publication as required by law.
