#### BERNARDSVILLE BOROUGH ORDINANCE #2019-1804

## AN ORDINANCE FIXING RESPONSIBILITY FOR THE REPAIR AND MAINTENANCE OF SEWER LATERALS AND SUPPLEMENTING AND AMENDING CHAPTER XVI OF THE BOROUGH CODE ENTITLED "SEWER REGULATION"

WHEREAS, it has been an unwritten Borough policy that property owners are responsible for the repair and maintenance of sewer laterals and that the Borough is only responsible for the repair and maintenance of sewer mains and manholes; and

WHEREAS, Borough Public Works Manager John Macdowall has recommended that this policy be codified in an ordinance;

NOW THEREFORE, BE IT ORDAINED by the Council of the Borough of

Bernardsville in the County of Somerset, State of New Jersey that Chapter XVI of the Borough

Code Entitled "Sewer Regulations" is hereby supplemented and amended as follows:

**Section 1.** There is hereby added a new subsection 16-5 entitled "Responsibility for Repair and Maintenance of Sewer Laterals".

"16-5 Responsibility for Repair and Maintenance of Sewer Laterals
The property owner shall be responsible for the repair and maintenance of
building laterals up to the branch connection at the public sewer main. The
Borough is only responsible for the repair and maintenance of sewer mains and
manholes."

Section 2. Any or all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

**Section 3.** In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 4.** This ordinance shall become effective immediately upon final passage and publication as required by law.

# AN ORDINANCE CREATING A CULTURAL ARTS ADVISORY COMMITTEE AND SUPPLEMENTING AND AMENDING CHAPTER II OF THE BOROUGH CODE ENTITLED "ADMINISTRATION"

**BE IT ORDAINED** by the Council of the Borough of Bernardsville in the County of Somerset, State of New Jersey, that Chapter II of the Borough Code Entitled "Administration" is hereby supplemented and amended as follows:

**Section 1.** There is hereby created a new Section 2-40 entitled "Cultural Arts Advisory Committee" which reads as follows:

### "2-40 CULTURAL ARTS ADVISORY COMMITTEE.

### 2-40.1 Membership; Terms.

The Committee shall consist of seven members. The Mayor shall appoint all the members of the Committee, with the advice and consent of the Council, and shall designate one of such members to serve as chairperson and presiding officer of the Committee. Members shall be appointed for a term of three years, except that the terms of two of the initially-appointed members shall expire on December 31, 2019, the terms of two of the initially-appointed members shall expire on December 31, 2020, and the terms of the remaining three initially-appointed members shall expire on December 31, 2021. No member of the Committee shall receive compensation for his or her service.

### 2-40.2 Purpose and Duties.

The Committee shall initiate, sponsor and celebrate local art, creativity and cultural activities including, but not limited to, art, photography, design, music, culinary arts, literature, drama and dance. The Committee will create opportunities to educate, inform and engage the community about cultural affairs and will organize and supervise events to showcase local creative talent."

Section 2. Any or all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

**Section 3.** In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 4.** This ordinance shall become effective immediately upon final passage and publication as required by law.





#### BOROUGH OF BERNARDSVILLE RESOLUTION 19-128 ADOPTING AN AFFORDABILITY ASSISTANCE MANUAL

WHEREAS, on March 10, 2015, the New Jersey Supreme Court issued its decision, In the Matter of the Adoption of N.J.A.C. 5:96 and 5:97 by the New Jersey Council on Affordable Housing, 221 N.J. I (2015). In that decision, the New Jersey Supreme Court transferred primary jurisdiction over affordable housing matters from the New Jersey Council on Affordable Housing ("COAH") to the New Jersey Superior Courts, and established a transitional process for municipalities, like the Borough of Bernardsville, to file declaratory judgment actions seeking to declare their Housing Element and Fair Share Plans ("HEFSP") as being constitutionally co pliant and to seek the judicial equivalent of substantive certification, which has been deemed by the Court to be a Judgment of Compliance and Repose and accompanying protection as provided under the Fair Housing Act of 1985; and

WHEREAS, on July 6, 2015, in accordance with the Supreme Court's decision, the Borough filed a declaratory judgment action that is captioned, <u>In the Matter of the Application of the Borough of Bernardsville</u>, County of Somerset, Docket No. SOM-L-925-15 (the "Litigation"); and

WHEREAS, in that filing, the Borough also sought a determination from the Superior Court regarding the Borough's future use and disposition of the Borough's Affordable Housing Trust Funds, as directed by the New Jersey Appellate Division in the case, In Re Failure of the Council on Affordable Housing to Adopt Trust Fund Commitment Regulations, Docket Nos. A-5257-11T4 and A-0122-13T3; and

WHEREAS, by Resolution approved on November 22, 2017 the Borough approved an Amended Settlement Agreement with the Fair Share Housing Center to settle the Litigation, and endorsed the Borough's 2018 Housing Element and Fair Share Plan (the 'HEFSP"); and

WHEREAS, as part of the Amended Settlement, the Borough's Planning Consultant prepared an Updated Spending Plan to provide an updated plan for the collection and distribution of development fee revenues to be used to support elements of the Borough's HEFSP; and

WHEREAS, by Resolution approved on May 29, 2018 the Borough approved an Updated Affordable Housing Spending Plan; and

WHEREAS, the Governing Body of the Borough of Bernardsville is required to spend at least 30% of its revenue from the Affordable Housing Trust Fund on Affordability Assistance, and that the Borough's Planning Consultant prepared a manual for the orderly distribution of revenues to be used to support the following elements of the Updated Spending Plan: Down Payment/Closing Cost Assistance, E emergency and Health/Safety Repairs, First

Month's Rent, Creation of Additional Very Low Income Units, Energy Efficiency Assistance, and a Bridge Loan,

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the Borough of Bernardsville, County of Somerset, State of New Jersey as follows:

- Section 1. The Council hereby approves the Affordability Assistance Manual and authorizes its Planning Consultant to begin soliciting applications for Affordability Assistance.
- Section 2. The Mayor, Borough Administrator, and Borough Clerk, together with all other officers, professionals and employees of the Borough are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Resolution.
  - Section 3. This Resolution shall take effect immediately.
